The Canadian Association of Midwives requires you to warrant the following:

- (a) that you are the author(s) and sole owner(s), that the article is original, not currently under consideration elsewhere and unpublished
- (b) that you have not previously assigned copyright or granted a license to any other third party;
- (c) that the article does not infringe any proprietary right of any third party
- (d) that you received the permissions necessary to include the work of others in the article;
- (e) that the article does not libel or violate the privacy rights of any third party.
- (f) that you have participated sufficiently in the work to take public responsibility for appropriate portions of the content.
- (g) that you have substantially contributed to the conception, composition, and revision of this article, and approved the final version to be published.

Authorship credit should be based only on:

- (a) substantial contributions to conception and design or acquisition of data or analysis and interpretation of data;
- (b) drafting the article or revising it critically for important intellectual content; and
- (c) final approval of the version to be published

Conditions (a),(b) and(c) must all be met. Acquisition of funding, collection of data, or general supervision of the research group, by themselves, do not justify authorship.

The authors hereby transfer all copyrights in and to the manuscript named above in all forms and media, now or hereafter known, to the *Canadian Association of Midwives* (CAM) effective if and when the manuscript is accepted for publication in the *Canadian Journal of Midwifery Research & Practice* (CJMRP).

The authors retain the following nonexclusive copyrights; to be exercised 6 months after the manuscript has been published in final format in the print version of the CJMRP.

- (a) Reprint the manuscript in print collections of the author's own writing.
- (b) Present the manuscript orally in its entirety (not subject to 6 months delay).
- (c) Use the manuscript in theses and/or dissertations.
- (d) Reproduce the manuscript for use in course(s) the author is teaching.
